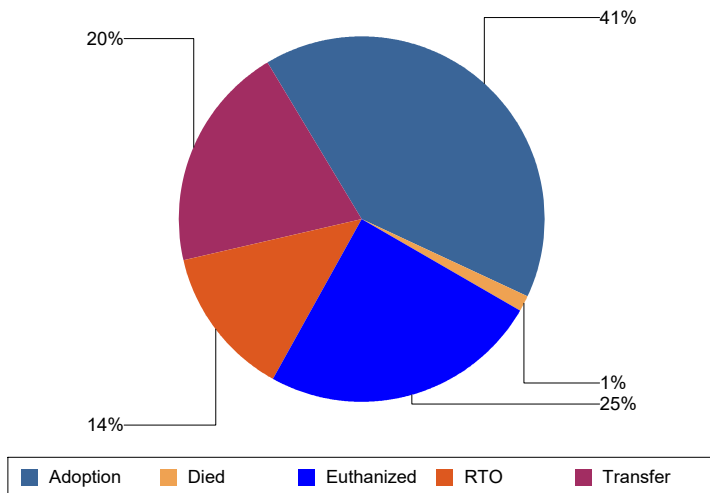

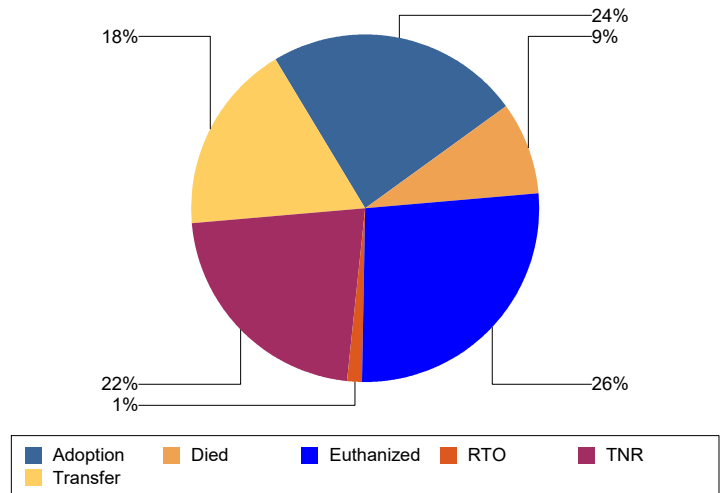

#### Feline Outcomes by Reason



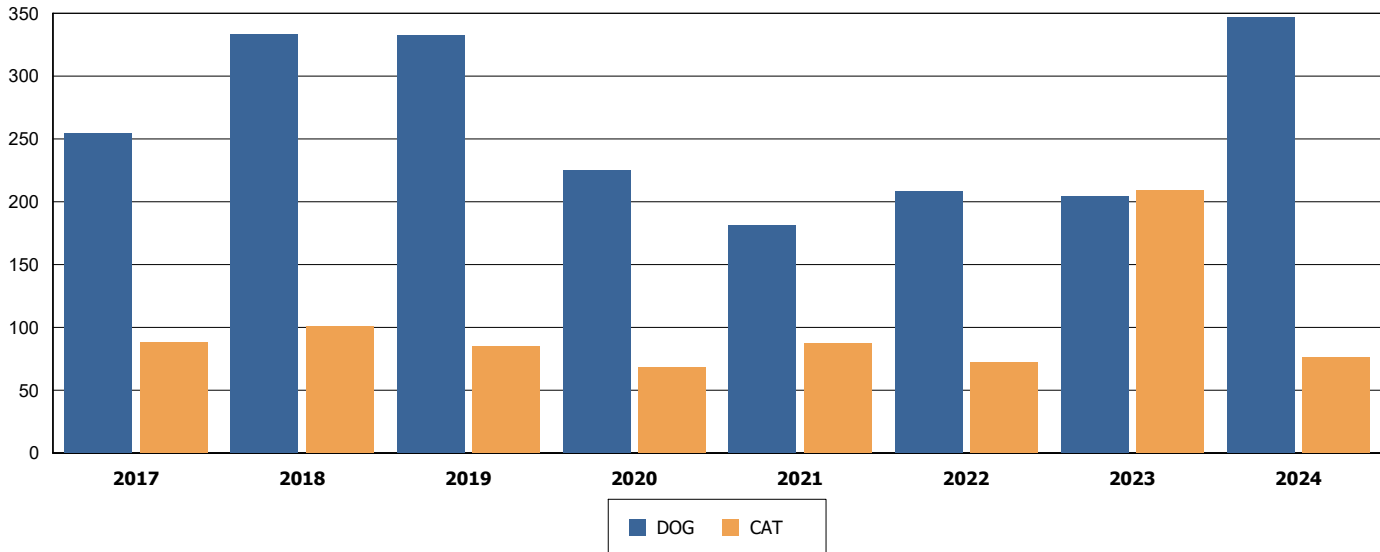

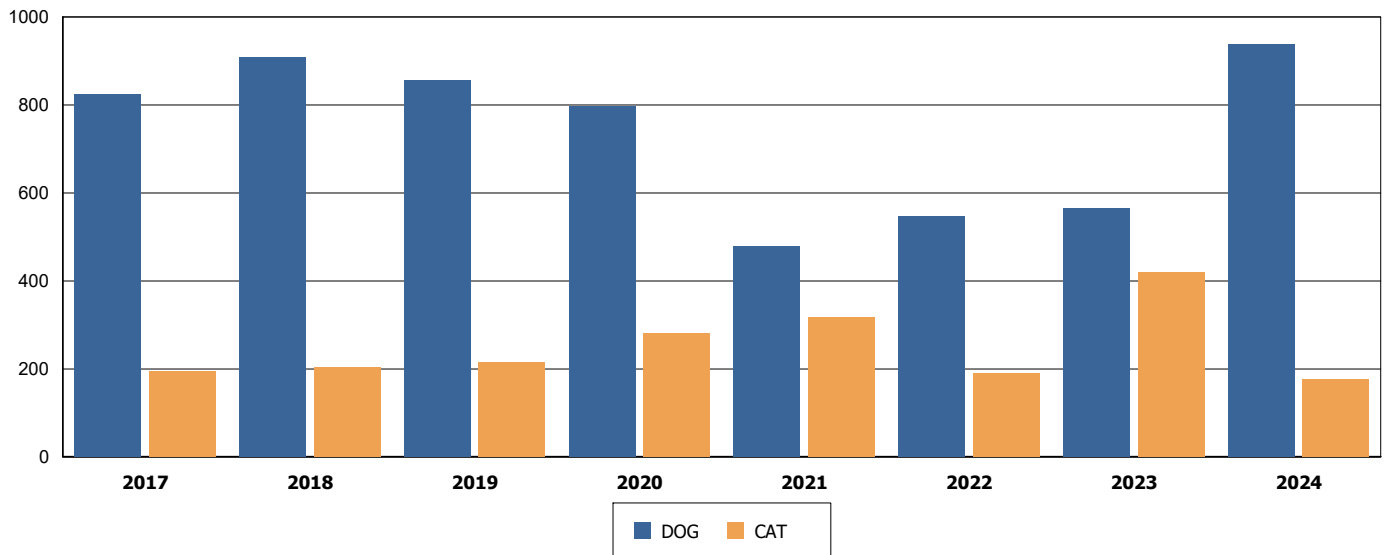
### Intake for 3/1/2025 to 3/31/2025 by Species for the Past Eight Years

Comparison Intake Calendar Year-to-Date



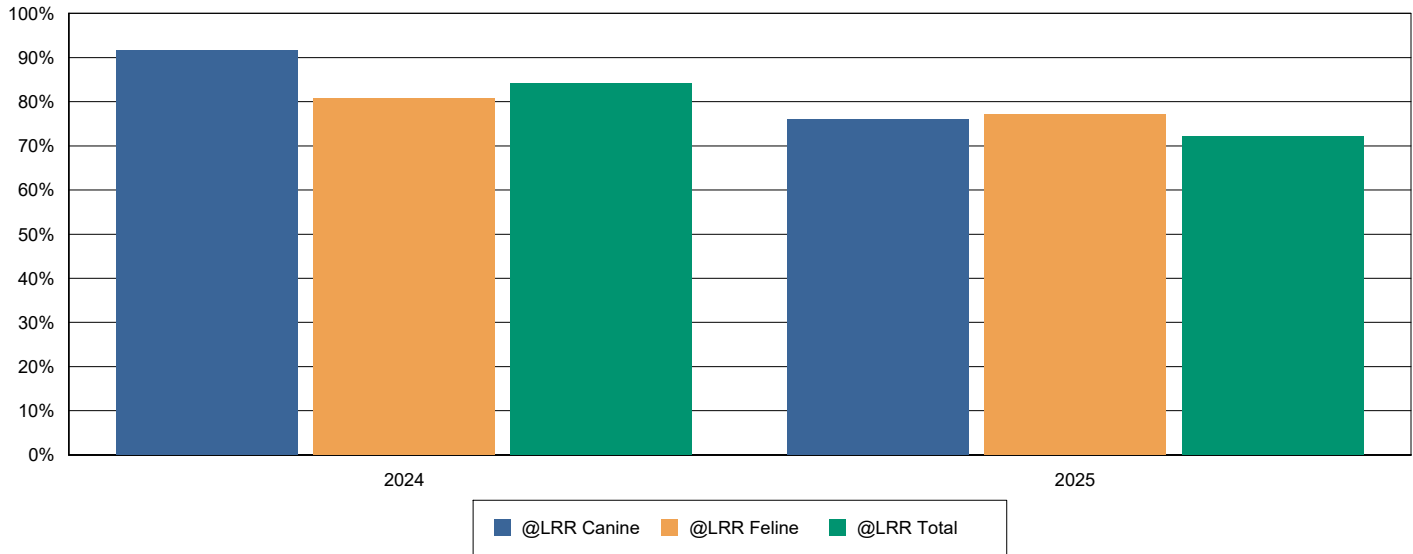

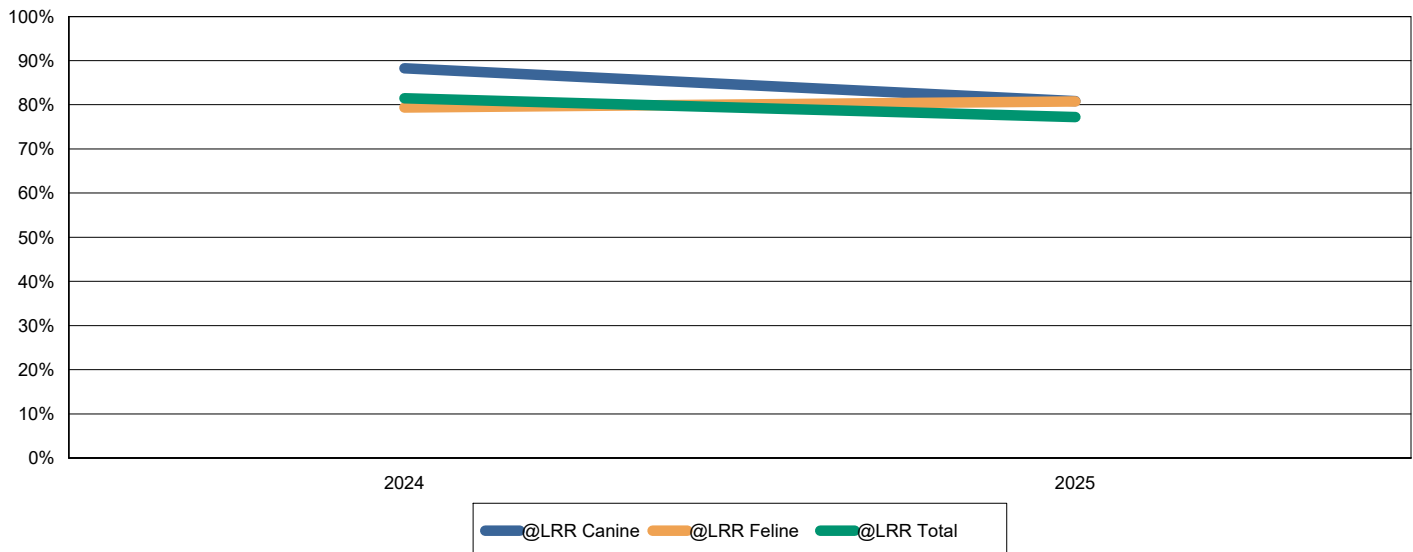
### Live Release Rate by Species for 3/1/2025 to 3/31/2025 for the Past Eight Years

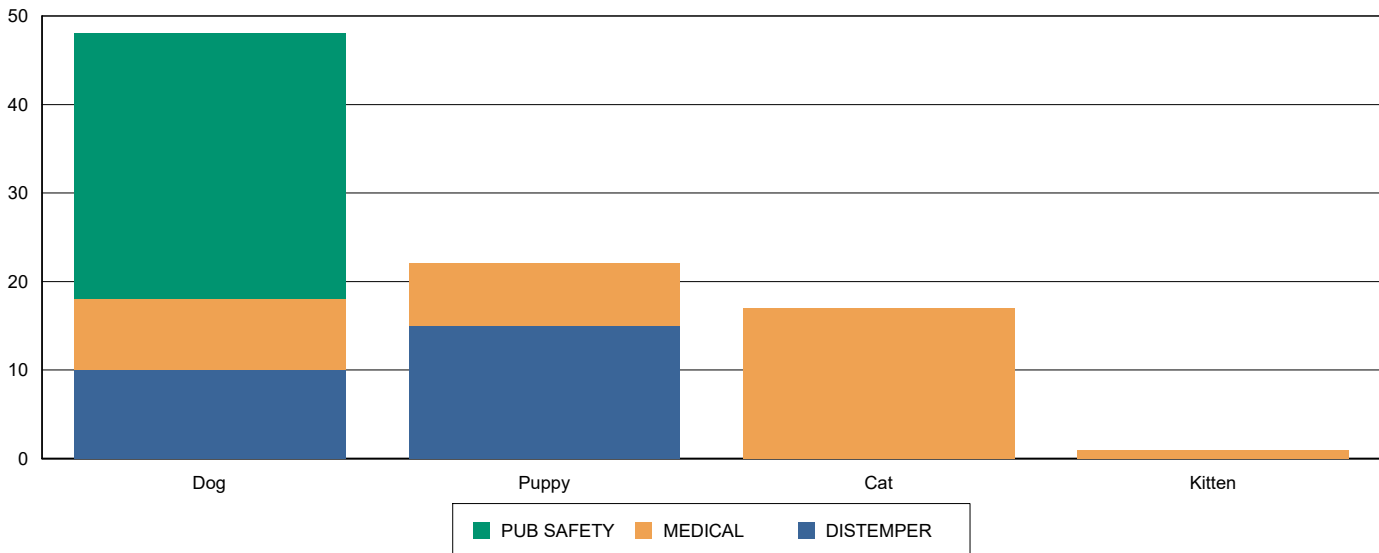
