### **Executive Summary**

As part of our annual audit plan, the City Auditor's Office (CAO) followed up on the AU24-010 Office of Emergency Management (OEM) – Disaster Recovery Plan dated September 24, 2024. The original audit aimed to assess the City of Corpus Christi's Disaster Recovery Plan for adequacy and preparedness testing.

The original audit made three recommendations: requiring Incident Command System (ICS) FEMA training for Level 300<sup>1</sup> staff who have direct and critical action roles during emergencies, offering language diversity options for public information, and updating the crisis management internet-based system, WebEOC.

Management accepted the recommendations from the original audit and agreed to implement the necessary process changes.

Management indicated that two of the three recommendations have been implemented, with one still in progress. Auditors then reviewed the submitted information and confirmed that two have been implemented while one remains in progress.

A complete list of recommendations and current statuses is available on page 1. Additional details about the recommendations in progress can be found in Appendix A.

We conducted this follow-up review in accordance with the Global Internal Audit Standards. These standards require that we confirm that management has implemented our recommendations or management's action plans. We inquired about the progress on implementation, performed follow-up assessments using a risk-based approach, and updated our tracker and Five-Year Follow-Up Dashboard to reflect issues and report this at every Audit Committee Meeting.

## **Appendix A: Additional Follow-up Information**

#### 1. Level 300 Series City Staff Not Completing ICS-300/400 FEMA Training

According to an Administrative Directive presented at an Executive Leadership meeting on February 16, 2023, and signed by the City Manager on the effective date, February 27, 2023, all employees in the 300 series must obtain certifications by successfully completing FEMA's Incident Command System training. The OEM is responsible for keeping records of the FEMA ICS course certifications for all 300 series employees. In the original audit, we found that 21% of Level 300 Series City staff had received the required FEMA ICS 300 and 400 training.

#### **Recommendation:**

Department directors and assistant directors who have direct and critical action roles during emergencies should be required to attend ICS 300 and 400. The CAO recommends revising the policy to allow the OEM to coordinate with city leadership to help determine which departments serve in critical roles during emergencies. Organizations in the area offer training, and the OEM will continue to release details via email to those department directors and assistant directors as upcoming ICS training information becomes available.
